### THE FACILITATION OF THE DEPLOYMENT

#### 1. Preparation and initiation by ENPO

- Realising the importance of the deployment
- Identifying the players of the process (Directorate of Informatics)
- Collecting the necessary technical information for the implementation
- Contacting the IT department and requesting the deployment

#### 2. Deployment by Directorate of Informatics

- Request from two parallel sources: ENPO and KIFÜ, the Hungarian National Research and Educational Network (NREN)
- Three working days to complete the task

Altogether two/three weeks for facilitation





### CHALLENGES AND OPPORTUNITIES

#### **Challenges**

Finding the best possible way to describe the request to the IT department

#### **Opportunities**

- Effective, well-functioning communication channels
  - established good cooperation between the IRO and the IT department → essential in digitalisation efforts of Erasmus+
- Having proper Identity Providers (IdP) and working operation solutions
  - working with eduGAIN for more than 10 years
  - many of the attributes required by the ESI already enabled





### THE OPTIMAL PROCESS OF DEPLOYING THE ESI

#### The optimal process would be:

#### 1. The process is initiated by the IRO

- finding the right unit that works with identity management
- providing the necessary instruction for the correct deployment of the ESI

#### 2. Technical task by the IT department

• publication of the necessary parameters towards the eduGAIN federation (ndr. in case the institution has such software)

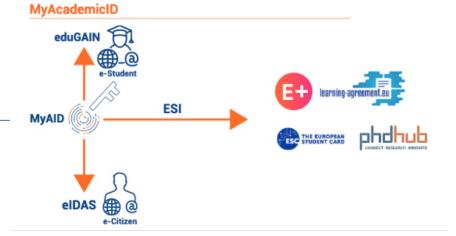
#### 3. Share the news with the stakeholders

students, coordinators, student organizations or any other relevant unit at the university
