Feedback collected between 21.03.2022 and 22.04.2022

700 respondents coming from 558 HEIs (11% of all ECHE holders) 419 completed

Approximate number of outgoing Erasmus exchange students prior to Covid (credit mobility)












What tool(s) do you use to manage the following processes?





What is the current status of IIAs & EWP at your institution?










What is the current status of LAs & EWP at your institution?








What is the status of implementation of the ESI at your HEI?







Functionalities : missing, lagging, not fit for purposes, not matching HEIs needs, unfinished	44
Technical issues, system errors	41
Time and resources consuming, increased workload (to implement or use)	29
Difficult to use, not user friendly, confusing, frustrating, outdated (project or application)	27



What tool do you use to manage processes related to Erasmus+ Traineeships?



How do you internally manage IIAs with HEI in Erasmus partner countries (so called international mobility)?





Traineeship certificate	7.2
Multilateral agreements	7.1






